THE SCHEDULE OF APPROVAL

1. PRODUCT DESCRIPTION

Fire retarding material is mineral wool "KNAUF INSULATION MHTB 700" (formerly named TERVOL BS-15), with 150 kg/m3 density and 48 mm thickness, lined from both sides with steel plate 0,6 mm in thickness. Total thickness of panel is 50 mm.

Adhesive ''ICEMA R145/8S'' (or "COSMO PU 160.460" or "KORAPUR 201") is used between steel plates and mineral wool for bonding.

The panels are fitted together by joint panel sides of male/female type.

2. APPLICATION/LIMITATION OF USE

"B-15" class fire protection on ships.

3. DESIGN DRAWINGS AND SPECIFICATIONS

Drawing No. PB-15-2008-00 "B-15 CLASS BULKHEAD" and drawing No. PB-15-2008-01 "TIBO PANELING SYSTEM TPS-2" (drawings attached to the Test Report).

4. TYPE TEST RECORDS/LABORATORY RECOGNITION STATUS

The testing in accordance with IMO 2010 FTP Code, Part 3 (IMO Resolution MSC.307(88)) has been carried out in LABORATORIJ ZA TOPLINSKA MJERENJA, Stubička Slatina, Croatia. The testing results have been stated in the Test Report No. I-3856/14-1, dated 22nd July 2014.

5. MATERIALS OR COMPONENTS REQUIRED TO BE TYPE APPROVED OR TYPE TESTED

The following components shall comply with the requirements of MED 96/98/EC, as amended, and be wheelmarked:

- the insulating material "KNAUF INSULATION MHTB 700", density 150 kg/m3 (Knauf Insulation d.o.o.)
- the adhesive materials "ICEMA R145/8S" or "COSMO PU 160.460" or "KORAPUR 201".

6. OTHER MATERIALS AND/OR COMPONENT

The surface materials, if used, have to be approved according to the Marine Equipment Directive and bear the Mark of Conformity.

7. PRODUCTION SURVEY REQUIREMENTS

The manufacturer is allowed to affix the Mark of Conformity to equipment referred and to issue a Declaration of Conformity as long as either of the following is fulfilled:
