# THE SCHEDULE OF APPROVAL

### 1. PRODUCT DESCRIPTION

Single leaf hinged door class "B-15"

The door leaf is composed of two steel sheets of 0.7 mm and insulating core of 40 mm "MHTB 700" with nominal density 150 kg/m3. Total door leaf thickness is 43 mm.

Door leaf is fitted to door frame with three hinges. Door frame is made of sheet steel with insulation inside.

Max size of clear opening is 800 x 2000 mm (W X H).

#### 2. APPLICATION/LIMITATION OF USE

"B-15" class fire protection on ships.

## 4. TYPE TEST RECORDS/LABORATORY RECOGNITION STATUS

The testing in accordance with IMO FTP Code Part 3 (IMO Res.A.754(18)) has been carried out in ZAG (ZAVOD ZA GRADBENIŠTVO), Ljubljana, Slovenija. The testing results have been stated in the Test Report No. P 953/04-530-1 dated 22<sup>nd</sup> July 2004.

# 5. MATERIALS OR COMPONENTS REQUIRED TO BE TYPE APPROVED OR TYPE TESTED

The following components shall to comply with the requirements of MED 96/98/EC, as amended, and be wheelmarked:

- the insulating material "MHTB 700" (ex product name TERVOL BSI-15), density 150 kg/m3, Knauf Insulation d.o.o.

#### OTHER MATERIALS AND/OR COMPONENT

The surface materials, if used, have to be approved according to the Marine Equipment Directive and bear the Mark of Conformity.

# 7. PRODUCTION SURVEY REQUIREMENTS

The manufacturer is allowed to affix the Mark of Conformity to equipment referred and to issue a Declaration of Conformity as long as either of the following is fulfilled:

- Module D The quality system for production and testing shall be approved by the Notified Body or,
- Module E The quality system for inspection and testing shall be approved by the Notified Body or,
- Module F Compliance of the products in this EC Type-Examination Certificate is to be verified by the Notified Body who shall also issue a Certificate of Conformity.

# 8. ONBOARD INSTALLATION AND MAINTENANCE REQUIREMENTS

Subject to compliance with the conditions in this Schedule of Approval which forms part of certificate, and those of Articles 10.1(i) and 11 of the Directive, the Manufacturer is allowed to affix the "Mark of Conformity" to the Product described herein.
