Postupak laminiranja drva se obavlja ručnim kontaktnim postupkom i vakumiranjem plastičnom folijom.

Wood lamination method is performed by hand lay-up and vacuum bagging.

1) Proizvodnja brodica, jahti i brodova duljine do 24 metra.

The manufacture of small vessels, yachts and ships of length up to 24 m.

2) Popravak brodica, jahti i brodova izrađenih od drva postupkom opločenja vanjske oplate u nekoliko hladno lijepljenih slojeva s epoksidnim smolama.

Repairing of small vessels, yachts and ships made of wood by method of plating of outer shell in several cold laminated layers with epoxy resins.
