Plutajući ponton tip M3312HD (HDS) je izrađen od armiranog beton čvrstoće 45 N/mm² ojačanog plastičnim vlaknima. Jezgra pontona je ekspanzirani polistiren gustoće 15 kg/m³. Čelična armatura je pocinčana vrućom galvanizacijom.

Floating pontoon type M3312HD (HDS) is made of steel reinforced plastic fibre concrete with strength 45 N/mm². Pontoon core is expanded polystyrene with density 15 kg/m³. Reinforcement is fully hot galvanized steel.
