*Mechanical and technological testings shall be carried out by a manufacturer in laboratories and institutions approved by the Register for that purpose.*

*The manufacturer may engage only the institutions approved by the Register to test by the non-destructive methods.*

*Heat treatment the manufacturer shall carry out only in the furnaces fitted with devices for controlling and indicating the temperature; these devices are to be checked at regular intervals.*

*If the supervision of ship valves and fittings class 1 and 2 as well as of ship side and bottom valves and fittings in welded construction, or of some of elements pointed by any welding method would be necessary, Register shall require the Certificate of professional ability of welders and the welding procedure qualification.*
