Prema proceduri QP7.5.1-3 Odobrenje uslužnih tvrtki

Kada je potrebno obavljati radove krpljenja i druge poslove zavarivanja i rezanja, suhi i mokri postupci podvodnog zavarivanja i rezanja moraju dobiti privremeno ili stalno odobrenje Registra.

Poslove podvodnog zavarivanja i rezanja moraju obavljati zavarivači/ronioci čije je kvalifikacije verificirao Registar.

Sve aktivnosti moraju biti obavljane u nazočnosti inspektora Hrvatskog registra brodova.

When patching works and other welding activities shall be done, dry and wet methods of the underwater welding and cutting shall be furnished with temporary or permanent approval.

All activities shall be performed in the presence of the Croatian Register of Shipping surveyor.

All equipment used in service shall be calibrated and maintained, regularly.
